TENANT(s) acknowledges and agrees that LANDLORD, the property owner and its agents shall not be liable for any personal injury to TENANT(s) or damage to TENANT's property arising out of the existence of the waterfront features on the Property and their use. LANDLORD, the property owner and its agents' insurance policy(s) do not cover any loss suffered by the TENANT(s). TENANT(s) is strongly advised to purchase insurance coverage on their personal belongings and liability coverage. TENANT(s) hereby acknowledge and agree to indemnify LANDLORD, the property owner and their agents for any injuries or damages suffered TENANT(s), their invitees, guests, agents or licensees arising out of the existence of the waterfront features on the Property and their use. TENANT(s) agrees to promptly notify LANDLORD in writing of any damage or defects to any of the waterfront features. TENANT(s) further acknowledges and agrees that it shall be liable for all damage to any waterfront feature due to the intentional or negligent acts by the TENANT(s), its invitees, guests, agents or licensees.
